3 YEAR WARRANTY

All pipettes carry three years warranty from the date of purchase, against defects in material and workmanship. We will repair or replace the defective product upon prompt notification in compliance with the conditions listed below

The warranty against defects in workmanship or materials will be accepted as long as the product has been used in compliance with the instructions for care and use. The warranty will be considered void if pipette is exposed to physical or chemical abuse. Routine cleaning and recalibration are not covered under the terms of the warranty.

This warranty is subject to the following conditions:

- . The customer must notify its authorized distributor in writing immediately after sighting of the defect.
- The product must be returned to its authorized distributor upon request. The complete cost of forwarding in such cases including transportation, applicable Government taxes, insurance is to be borne by the customer.
- Our responsibility extends only to product defects. The warranty does not apply if, in opinion of the product has been damaged by
 accident, misuse, chemical or physical corrosion and/or by service or modification by someone other than an authorized service
 provider.

CERTIFICATE

We declare that all pipettes are manufactured and verified by technicians authorized by us under strictly defined and monitored conditions, according to the ISO 8655-6 standard.

Before dispatching, all pipettes are calibrated in the laboratory by using distilled water grade 3 (ISO 3696) at controlled room temperature, relative air humidity (minimum 50%) and barometric pressure (1013hPa).

Ten measurements are taken at each test volume (nominal, 50% nominal, minimum or 10% nominal whichever is higher). Balances are regularly checked with weight traceable to national and international standards.

Quality system and procedure is well defined and maintained as per ISO 9001:2015 and is regularly audited by external agencies.
